SEPTEMBER 9, 2015

1. CALL TO ORDER

President Jerry Brown called the meeting to order at 7:05 p.m. Board members in attendance were Dean Abell, Angus Beverly, Connie Boukidis, Jerry Brown, Sandy Brown, David Burke (voted in during the course of the meeting), Lisa Chapman, Roozbeh Farahanipour, Ann Hayman, Mitchell Keiter, Stephen Resnick, Marcello Robinson, Scott Whittle, and Laura Winikow. Board members excused were Jacob Finn, Mark Rogo, and Eugene Tseng. A quorum was present. There were 25 stakeholders and guests present.

2. APPROVAL OF MINUTES

Scott Whittle moved to approve the minutes of the July 8, 2015 meeting. Roozbeh Farahanipour seconded the motion, which carried unanimously.

3. COMMENTS BY PUBLIC OFFICIALS

A. West LAPD Senior Lead Officer Chris Ragsdale reported that crime is starting to trend down after a spike. He introduced the maker of the Ring Video Doorbell, who gave a presentation on his company's product which has a Neighborhood Watch feature and was developed in concert with the LAPD.

B. Mayoral representative Daniel Tamm reported on recent activity in the Mayor's office: the LAPD body camera initiative, and the effort to house homeless veterans with the Homes for Heroes plan.
C. CD5 Field Deputy Jasmine Shamolian introduced herself as the new deputy.

"The WWNC LUPC recommends that the WWNC BOD support the application by BJ's

Pizza Grill for a conditional use permit for sale and expansion into adjacent 812 sf space,

proposed façade improvements, installation of one village pedestrian blade sign and

modification of existing wall sign on the condition that Applicant is committed and

agrees to seek a conditional liquor license type 47 with the ABC and only accept such

conditional license that includes the following conditions:

-No Happy Hour; no pitchers of beer or wine sold; no beer for

sale signs outside; no speakers outside; 6 pack microbrew can

only be sold off-site in conjunction with food; no kegs or

growlers sold on or off-site; and tables that are located in bar area in

present rendition remain in bar area.

In addition, the WWNC BOD urges Applicant BJ's Pizza Grill that in addition with its full

liquor license, it implement a full menu on par with its restaurants located in Century

City, Pasadena, Culver City etc."

The motion was seconded by Ann Hayman. The motion carried by a vote of Yes: 11,

No: 2 (Lisa Chapman, Mitchell Keiter), and Abstain: 1 (Dean Abell).

A. Possible Motion regarding project

Chair Connie Boukidis reported that Rocco's Tavern wants to install a 14 foot wide garage door that opens onto the sidewalk. It is diagonally across the street from the Gayley Terrace Apartments, a historic-cultural monument. The owner and manager of the Gayley Terrace Apartments were present and said that they already had many complaints from residents about the noise generated by Rocco's Tavern patrons, and this

would make noise problems worse. Rocco's Tavern representative Jason Summers spoke

as well, saying that there would be limits on hours open and how the tavern is accessed.

Connie Boukidis moved.

"Due to the long history of complaints associated with this corner at Gayley and Weyburn, the WWNC LUPC unanimously recommends that the WWNC BOD oppose the present project design for the ROCCO PROJECT. The WWNC BOD supports only inoperable garage doors and windows for the following reasons, including, but not limited to,

- noise concerns;
- nuisance concerns;
- public safety concerns;
- their potential negative impact on the historical monument known as the Gayley

Terrace Apartments located across the street; and

- its desire to encourage compliance with two of the seven PURPOSES set forth in the Westwood Village Specific Plan, specifically, in "Section 2.B. To permit, encourage, and facilitate the preservation, renovation, and ongoing maintenance of historically and architecturally significant buildings." and Section 2.G. To mitigate the impacts of Village development on nearby residential areas."

The motion was seconded by Marcello Robinson, and carried by a vote of Yes: 13, No: 1 (Angus Beverly), and Abstain: 0.

"The WWNC supports the application by Café Chez Marie to extend their nightly closing time by three hours, from their current 7:00 p.m. to a requested new closing time of 10:00 p.m. and their request for a waiver of public hearing in connection with this request."

The motion was seconded by Sandy Brown and was carried unanimously.

A special thank you was given to Aurelia Friedman and Armen Hadjimanoukian for their

service to the community as former WWNC board members.

DONE Director of Outreach Stephen Box explained that there is no vote by mail option for the 2016 elections because it was discarded in favor of online voting, and said that WWNC had to vote on approval of online voting for the election tonight. Jay Handal spoke as well. During a lengthy back and forth, points made by WWNC board members were that this disenfranchises the elderly and doesn't take into account WWNC's history as being one of the highest vote-getting Neighborhood Councils in the City.

Sandy Brown moved, seconded by Angus Beverly, "WWNC will inform CD5 and the Mayor that it would like their support to go to DONE and reinstate Vote by Mail for WWNC for the 2016 election." Mitchell Keiter amended the motion to add, "taking into account WWNC's

history of voting." The amendment was seconded by Ann Hayman, and the amended motion carried unanimously.

Dean Abell moved, seconded by Marcello Robinson, "WWNC approves online voting in the 2016 elections with a change from self-affirmation to documentation." The motion was defeated by a vote of Yes: 5 (Dean Abell, David Burke, Lisa Chapman, Marcello Robinson, and Laura Winikow), No: 9 (Angus Beverly, Connie Boukidis, Jerry Brown, Sandy Brown,

Roozbeh Farahanipour, Ann Hayman, Mitchell Keiter, Stephen Resnick, and Scott Whittle), and Abstain: 0.
