The Brentwood Westwood Symphony Orchestra (BWSO) has a mission to serve and engage a diverse audience of all ages in nearby Los Angeles communities through the performance of powerful living music, creative educational programs, and strong community relationships. The Symphony is requesting funds of \$5,000 for performance operating support to sustain and enhance its outreach programs. Through generous pledged support from loyal donors it offers free concerts and music performance opportunities for residents in the community. We would like to produce a smaller Spring 2012 concert in a Westwood venue, to support both of our communities. We have already established concerts in Brentwood.

5) How will this grant be used to primarily support or serve a non-discriminatory, public purpose and benefit the public at-large.

Since its founding in 1953 it has continued to enhance the community by offering FREE concerts and support to musicians. Each season it provides musical talent of the highest caliber, which includes very dedicated notable musicians, guest conductors, student winners, new composers, and distinguished soloists who perform a wide variety of works.

The six key initiatives of the Symphony are to 1) Promote free classical music to the local community at a time when popular music is gaining audience attention; 2) Provide competition venues and scholarships to support young artists; 3) Take music assembly and special concerts to low-income K-12 schools to enhance or replace music programs; 4) Support local musicians through outreach participation opportunities to advance their performance skills; 5) Offer experiential programs to college music majors to work with an orchestra; and 6) Introduce the community to new composers and a wide variety of innovative new music.
